**A RESOLUTION REQUIRING ALL BUSINESS ESTABLISHMENTS WITHIN THE

WHEREAS, the Acting Municipal Mayor Honorable Ariel P. Amador presented to this August Body a Letter of Endorsement entitled "A resolution requesting all business establishments within the Municipality of Marilao, Bulacan to Regularly submit updated lists of Job vacancies to the Public Employment Service Office (PESO)." for its appropriate action;

WHEREAS, pursuant to Section 16 of RA 7160, otherwise known as the Local Government Code of 1991, states that: "*xxx. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, xxx, promote full employment among their residents, xxx.*";

WHEREAS, the unemployment rate in the country is fast increasing due to uninformed job seekers or limited job vacancies;

WHEREAS, as a member of the Marilao's business community, it is imperative for them to assist in reducing at a faster pace the uninformed job seeker;

WHEREAS, the employment process can be speed up by maintaining a regular submission of updated lists of job vacancies in Public Employment Service Office (PESO) in the Municipality of Marilao;

RESOLVED FINALLY, that a copy of this Resolution be furnished to the Municipal Mayor and all other concerned parties for their information and appropriate action.


