WHEREAS, in Section 34 of the Local Government Code of 1991 (Republic Act No. 7160) supports the creation and operation of people's organizations (POs) and non-governmental organizations (NGOs) in the promotion of local autonomy;

WHEREAS, Article 62, Rule XIII of the Implementing Rules and Regulations (IRR) of Local Government Code 1991 strengthens the aforementioned provision, emphasizing that NGOs and POs should be included in the planning and execution of local government projects and activities, participate in local special bodies, and assist in the delivery of public services;

WHEREAS, Civil Society Organization shall comply with all the requirements and criteria set forth in the DILG Memorandum Circular 2025-060, and their programs and projects should have a contribution to the Local Government Unit of Marilao;

WHEREAS, numerous associations and organizations in the municipality have responded with enthusiasm to assist the municipal government in the effective implementation of programs, projects, and activities in the local level;

WHEREAS, Arthur C. Bueno, President of Almighty Inc. has expressed intention to be accredited and eventually become partner in any local government undertaking;

WHEREAS, Almighty Inc. has complied with all the requirements for accreditation except its **Certificate of Registration**;

NOW, THEREFORE, on motion of Councilor Vanessa Valdez-Seminiano, duly seconded by Councilor Harvey C. Mediante and upon unanimous vote;
