




WHEREAS, the said Department Order establishes the rules and guidelines on the automatic income classification of provinces, cities, and municipalities;

WHEREAS, pursuant to Section 6 of Republic Act (RA) No. 11964, or the Automatic Income Classification of Local Government Units (LGUs) Act, the Department of Finance (DOF) is mandated to issue the appropriate department order on the schedule of income classification which shall serve as certification of the income classification of LGUs;
