Sy, for and on behalf of the Municipal Government of Marilao, to request financial assistance from the Philippine Amusement and Gaming Corporation (PAGCOR) amounting to Fifty Million Pesos (P50,000,000.00) for the construction of a State-of-the-Art Digital and Information Technology (IT) Center in the Municipality of Marilao, Province of Bulacan.*" for its appropriate action;

**WHEREAS**, the Municipality of Marilao has emerged as a rising hub for industry, trade, and community development, consequently embracing a new vision, one driven by digital innovation and future-ready infrastructure and presume that digital transformation is not only inevitable but essential to inclusive growth and public service modernization;
