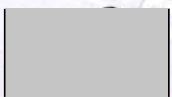

WHEREAS, the Office of the Municipal Mayor presented to this August Body a Letter of Endorsement entitled "*A Resolution authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign the Data Turnover Agreement (DTA) with the Philippine Statistics Authority (PSA), represented by its Regional Director, Arlene M. Divino, for the Turnover of the 2024 Community-Based Monitoring System (CBMS) data in the Municipality of Marilao, Province of Bulacan.*" for its appropriate action;

WHEREAS, the Community-Based Monitoring System (CBMS) was established and instituted in every city and municipality as an economic and social tool for the formulation and implementation of poverty alleviation and development programs that are specific, targeted, and responsive to the basic needs of each sector of the community pursuant to Republic Act (RA) No. 11315 or the Community-Based Monitoring System Act;

WHEREAS, pursuant to PSA Board Resolution No. 04, Series of 2024, a simultaneous conduct of the 2024 Census of Population (POPCEN) and CBMS conducted from July to September 2024 to update the mid-decade inventory of the population of the entire Philippines and update the social registries of national government agencies and local government units for evidence-based project development and program implementation;

WHEREAS, R.A. No. 11315 provides that the cities and municipalities can maintain their CBMS database for local-level planning and program implementation, and the PSA shall receive and store all aggregated data gathered by the cities and municipalities to create a national CBMS databank;

WHEREAS, the PSA, as the lead agency in the implementation of R.A. No. 11315 shall undertake measures to ensure the integrity and safety of the gathered information against unnecessary leakage and access by unauthorized persons.

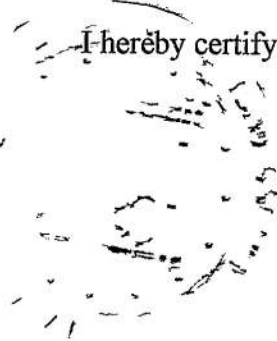
