




**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE ATTY. JEMINA M. SY, FOR AND ON BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, TO ENTER INTO AND SIGN THE GENERAL MEMORANDUM OF AGREEMENT (GMOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT-FIELD OFFICE III (DSWD FO III), REPRESENTED BY ITS REGIONAL DIRECTOR VENUS F. REBULDELA, FOR THE IMPLEMENTATION OF THE SOCIAL PROTECTION PROGRAMS INCLUDING THE PANTAWID PAMILYANG PILIPINO PROGRAM (4PS) AND OTHER POVERTY REDUCTION INITIATIVES IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.**

**WHEREAS**, the Office of the Municipal Mayor presented to this Body a Letter of Endorsement entitled "*A Resolution authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign the General Memorandum of Agreement (GMOA) with the Department of Social Welfare and Development-Field Office III (DSWD FO III), represented by its Regional Director Venus F. Rebuldelela, for the implementation of the Social Protection Programs including the Pantawid Pamilyang Pilipino Program (4Ps) and other poverty reduction initiatives in the Municipality of Marilao, Province of Bulacan.*" for its appropriate action;

**WHEREAS**, "DSWD" envisions a society where the poor, vulnerable and disadvantaged individuals, families, and communities are empowered for an improved quality of life and takes protection of the poor and marginalized members of society as its main mission otherwise known as Social Protection;

**WHEREAS**, Local Government Unit is mandated by Local Government Code (Republic Act No. 7160) to address the needs of its constituencies, and empower the people through direct participation in the affairs of the government, by allowing them the widest possible space to participate, decide on, initiate, implement, and innovate on development activities that address their identified needs;

**WHEREAS**, "DSWD" and "LGU" are willing and able to partner with each other to deliver a package of services in order to address poverty, empower citizens and promote inclusive growth, composed of some or all of the following PPAs for Poverty Reduction Programs and Social Protection Programs such as:

1. Pantawid Pamilyang Pilipino Program
2. Sustainable Livelihood Program
3. Disaster Management
4. Social Pension Program for Indigent Senior Citizen
5. Assistance to Individuals in Crisis Situation
6. Supplementary Feeding Program
7. Comprehensive Program for Street Children, Street Families, especially Indigenous People's, and
8. KC-NCDDP (in case of program extension by 2020)
9. Replication of Completed Social Technology Projects
10. Recovery and Reintegration Program for Trafficked Persons (RRPTP)
11. International Social Welfare Services for Filipino Nationals (ISWSFN)

**NOW THEREFORE**, on motion of Hon. Vanessa Valdez-Seminiano, duly seconded by Honorable Juanito H. Santiago and upon unanimous vote, for in consideration of the foregoing premises, DSWD and LGU hereby agree as follows:
