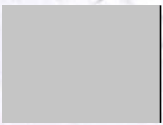

WHEREAS, the Office of the Municipal Mayor presented to this Body a Letter of Endorsement entitled, "A Resolution authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign the Specific Implementation Agreement (SIA) with the Department of Social Welfare and Development Field Office III (DSWD FO III), represented by its Regional Director, Venus F. Rebuldela, for the implementation of the Pantawid Pamilyang Pilipino Program (4Ps) in the Municipality of Marilao, Province of Bulacan," for its appropriate action;

WHEREAS, Section 444(a)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Municipal Mayor shall, upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Department of Social Welfare and Development (DSWD) envisions a society where the poor, vulnerable, and disadvantaged individuals, families, and communities are empowered for an improved quality of life, and takes the protection of the poor and marginalized members of society as its main mission, otherwise known as social protection;

WHEREAS, Local Government Units are mandated by the Local Government Code (Republic Act No. 7160) to address the needs of their constituents, and empower the people through direct participation in the affairs of government by allowing them the widest possible space to participate, decide on, initiate, implement, and innovate development activities that address their identified needs;

WHEREAS, the SIA serves as a supplementary document to implement the General Memorandum of Agreement (GMOA) executed between the Department of Social Welfare and Development Field Office III and the Local Government Unit of Marilao;

WHEREAS, both parties shall adhere to the roles and responsibilities contained in the SIA for the implementation of the Pantawid Pamilyang Pilipino Program in the Municipality of Marilao;

NOW, THEREFORE, on motion of Hon. Vanessa Valdez-Seminiano, duly seconded by Hon. Juanito H. Santiago, and upon unanimous vote,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to approve the above-mentioned Resolution of this Honorable Sangguniang Bayan of Marilao, Bulacan;

RESOLVED FURTHER, that the said Agreement shall take effect on the date of signing by both parties;

RESOLVED FINALLY, that a copy of this Resolution be furnished to the Municipal Mayor and all other concerned offices for their information and appropriate action.

APPROVED, by the 12th Sangguniang Bayan, this 27th day of October 2025.


