WHEREAS, the Municipal Mayor Hon. Atty. Jemina M. Sy, presented to this August Body a First Endorsement Letter entitled "*A Resolution concurring to the Appointment of Mrs. Miriam D. WHEREAS, the Sangguniang Bayan interposes no objection to said appointment;
