WHEREAS, the Municipal Mayor Hon. Atty. Jemina M. Sy, presented to this August Body a First Endorsement Letter entitled: "*A resolution Authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, to conduct a Christmas Bazaar featuring Local Products and to enter into Contracts with Participating Vendors and Suppliers for the purpose.*" for appropriate action;

WHEREAS, the Sangguniang Bayan finds the proposed activity aligned with the municipality's economic and tourism development goals, and supportive of local entrepreneurs;
