SY, TO WITHDRAW, ON BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, THE PROVISIONAL DEPOSIT MADE BY THE NATIONAL GRID CORPORATION OF THE PHILIPPINES (NGCP) IN FAVOR OF THE FORMER AS JUST COMPENSATION FOR THE COST OF AFFECTED STRUCTURES RELATING TO THE PROPERTY EXPROPRIATED BY THE LATTER.

WHEREAS, the Municipal Mayor, Hon. Atty. Jemina M. Sy, presented to this August Body a First Endorsement Letter entitled: "*A Resolution Authorizing the Honorable Municipal Mayor, Atty. Jemina M. Sy, to Withdraw, on Behalf of the Municipal Government of Marilao, the Provisional Deposit made by the National Grid Corporation of the Philippines in favor of the former as Just Compensation for the cost of affected structures relating to the property expropriated by the latter,*" for appropriate action;

WHEREAS, the Municipal Government of Marilao, through the Municipal Legal Office, filed a Motion to Withdraw Provisional Deposit amounting to Two Million Nine Hundred Twenty-Six Thousand Six Hundred Forty-One Pesos and Twenty-Five Centavos (₱2,926,641.25), made by the National Grid Corporation of the Philippines in favor of the Municipal Government of Marilao, representing the cost of replacement for the affected structures relative to Civil Case No. 390-M-2022, *National Grid Corporation of the Philippines vs. Municipality of Marilao*;

WHEREAS, in a Resolution promulgated on September 23, 2025, Presiding Judge Honorable Efren B. Tienzo of Regional Trial Court, Branch 13, ordered the Office of the Clerk of Court, Regional Trial Court in Malolos City, to release the aforementioned amount from the provisional deposit of Eleven Million One Hundred Thirty-Four Thousand Two Hundred Eighty-Five Pesos and Fifty-One Centavos (₱11,134,285.51) in favor of the Municipal Government of Marilao through its duly authorized representative;

WHEREAS, the said amount shall serve as just compensation for the properties and structures affected by the transmission line project undertaken by the National Grid Corporation of the Philippines;

NOW, THEREFORE on motion of Honorable Vanessa Valdez-Seminiano, duly seconded by Hon. Divina E. Reyes and upon unanimous vote.

BE IT RESOLVED, as it is hereby resolved, to authorize the Honorable Municipal Mayor, Atty. Jemina M. Sy, to withdraw, on behalf of the Municipal Government of Marilao, the Provisional Deposit made by the National Grid Corporation of the Philippines amounting to Two Million Nine Hundred Twenty-Six Thousand Six Hundred Forty-One Pesos and Twenty-Five Centavos (₱2,926,641.25), in accordance with the Order of the Regional Trial Court, Branch 13, Malolos City, Bulacan.

RESOLVED FURTHER, that the appropriate municipal offices extend the necessary assistance to ensure compliance with the court's directive and facilitate the release and proper utilization of said funds.

RESOLVED FINALLY, that copies of this Resolution be furnished to the Office of the Municipal Mayor, the Municipal Legal Office, the Municipal Treasurer's Office, and other concerned offices for their information, guidance, and appropriate action.
