WHEREAS, the Municipal Mayor, Hon. Atty. Jemina M. Sy, presented to this August Body a First Endorsement Letter entitled: "A Resolution approving and adopting MDC Resolution No. 2025-06, 'A Resolution programming the FY 2026 Annual Investment Program (AIP) and Twenty Percent (20%) Development Fund, embodying the various proposed development Programs, Projects and Activities (PPAs) of the Municipality of Marilao, Province of Bulacan, for Fiscal Year 2026, in the amounts of ₱4,673,918,000.00 and ₱195,000,000.00, respectively,'" for appropriate action;

WHEREAS, Section 447(a) of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, provides that the Sangguniang Bayan shall enact ordinances, approve resolutions, and appropriate funds for the general welfare of the municipality and its inhabitants;

WHEREAS, Section 109 of the same Act provides for the formulation of long-term and annual socio-economic development plans and policies by the concerned Local Development Councils;

WHEREAS, the Municipal Development Council, through its technical secretariat, shall align the local development plan with current development issues and ensure that the budget is linked to the plans, with the end objective of improving general welfare and the delivery of basic services;
