**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled "*A Resolution Authorizing the Municipal Mayor, Honorable Atty. **WHEREAS**, the Municipality has prepared a comprehensive list of priority development projects aimed at addressing the urgent infrastructure and social needs of the community, with an estimated total project cost of **Sixty-Seven Million Seven Hundred Forty Thousand Pesos (₱67,740,000.00)**;

**WHEREAS**, it is proper and necessary to authorize the Municipal Mayor to formally request financial assistance from Senator Bong Go to ensure the timely and effective implementation of these projects;

**NOW THEREFORE**, on motion of Councilor Vanessa Valdez-Seminiano, duly seconded by Councilor Maria Luisa I. Silvetre, and upon unanimous vote;


