




WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled "A Resolution Authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to request financial assistance from **Honorable Senator Joseph Victor "JV" G. Ejercito** for the implementation of various priority development projects in the Municipality of Marilao, Province of Bulacan, with a total project cost of Sixty-Seven Million Six Hundred Thousand Pesos (P67,600,000.00)." for appropriate action;

WHEREAS, the Municipality of Marilao, Bulacan continuously seeks ways to improve its public services, local infrastructure, and overall development for the welfare of its constituents;

WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, recognizes the need for additional funding to implement various priority development projects within the Municipality;

WHEREAS, **Honorable Senator Joseph Victor "JV" G. Ejercito** has consistently extended support to local government units for the implementation of projects that enhance public services and community development;

WHEREAS, Section 22 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers Local Government Units to enter into agreements and seek financial assistance from the national government, private sector, and other sources for the implementation of development projects;

WHEREAS, the Municipality has prepared a comprehensive list of priority development projects aimed at addressing the urgent infrastructure and social needs of the community, with an estimated total project cost of Sixty-Seven Million Six Hundred Thousand Pesos (P67,600,000.00);

WHEREAS, it is proper and necessary to authorize the Municipal Mayor Atty. Jemina M. Sy to formally request financial assistance from **Honorable Senator Joseph Victor "JV" G. Ejercito** to ensure the timely and effective implementation of these projects;

NOW THEREFORE, on motion of Councilor Vanessa Valdez-Seminiano, duly seconded by Councilor Maria Luisa I. Silvetre, and upon unanimous vote;


BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Sangguniang Bayan of Marilao, Bulacan hereby **authorizes the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to request financial assistance from Honorable Senator Joseph Victor "JV" G. Ejercito** for the implementation of various priority development projects in the Municipality of Marilao, Province of Bulacan;

RESOLVED FURTHER, that the Municipal Mayor is authorized to sign all necessary documents, communications, and correspondences related to this request for financial assistance;
