**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE ATTY. JEMINA M. SY, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE UNIVERSITY OF SANTO TOMAS – COLLEGE OF NURSING FOR THE IMPLEMENTATION OF RELATED LEARNING EXPERIENCE (RLE), COMMUNITY DEVELOPMENT PROGRAMS, AND OTHER ACADEMIC-COMMUNITY PARTNERSHIP ACTIVITIES IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.**

**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled “A Resolution authorizing the Municipal Mayor Honorable Atty. Jemina M. Sy, to enter into a Memorandum of Understanding (MOU) with the University of Santo Tomas-College of Nursing for the implementation of Related Learning Experience (RLE), Community Development Programs, and other Academic-Community Partnership Activities in the Municipality of Marilao, Province of Bulacan.” for appropriate action;

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the “Local Government Code of 1991,” provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare;

**WHEREAS**, Section 22(c) of the same Code authorizes the Local Chief Executive to represent the municipality in all its business transactions and to sign, on its behalf, all documents, contracts, and instruments, upon authority of the Sangguniang Bayan;

**WHEREAS**, the University of Santo Tomas – College of Nursing (UST-CON), being a recognized institution of higher learning, implements Related Learning Experience (RLE)

programs that require students to engage in supervised clinical and community health training in partnership with local government units and public health facilities;

**WHEREAS**, the Municipality of Marilao values collaboration with academic institutions to strengthen its community health programs and recognizes that such partnerships contribute to improved service delivery, capacity-building, and community development;

**WHEREAS**, the proposed Memorandum of Understanding (MOU) aims to establish cooperative arrangements for the implementation of RLE activities, community development initiatives, and other academic-community partnership programs that will benefit both the students of UST-CON and the residents of Marilao;

**WHEREAS**, it is deemed necessary and advantageous for the Municipal Government of Marilao to formalize this partnership by authorizing the Municipal Mayor to enter into and sign the MOU with the University of Santo Tomas – College of Nursing;


**NOW THEREFORE**, on motion of Councilor Vanessa Valdez-Seminiano, duly seconded by Councilor Maria Luisa I. Silvetre, and upon unanimous vote;

**BE IT RESOLVED**, as it is hereby resolved, to authorize the Municipal Mayor, Honorable Atty. Jemina M. Sy, to enter into and sign a Memorandum of Understanding (MOU) with the University of Santo Tomas – College of Nursing for the implementation of Related Learning Experience (RLE) programs, community development activities, and other academic-community partnership initiatives in the Municipality of Marilao, Province of Bulacan.


**RESOLVED FURTHER**, that a copy of this resolution be furnished to the Municipal Mayor and all other concerned parties for their information and appropriate action.
