



**RESOLUTION ADOPTING THE LOCAL CULTURAL INVENTORY OF THE  
MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.**

**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy presented to this August Body a first endorsement entitled "Resolution adopting the Local Cultural Inventory of the Municipality of Marilao, Province of Bulacan" attached herewith is the Marilao Tourism, Arts, and Culture Council Resolution No. 01, Series 2025 for appropriate action;

**WHEREAS**, *Section 14 (b) of Republic Act No. 10066*, otherwise known as the "*National Cultural Heritage Act of 2009*," requires local government units to establish and maintain a local cultural property or registry;

**WHEREAS**, in compliance thereto, Joint Memorandum Circular No. 2018-01 of the National Commission on Culture and Arts (NCCA) and the Department of Interior and Local Government (DILG) dated October 9, 2018 is enjoining all local government units to establish and maintain a local inventory of cultural property which shall form part of the Philippine Registry of Cultural Property (PRECUP);

**WHEREAS**, the Municipal Government of Marilao has submitted for the consideration and adoption of the Body an inventory of properties which are deemed to be cultural properties of the municipality for the inclusion in the PRECUP;

**WHEREAS**, the Sangguniang Bayan considers the said inventory of the municipal cultural properties reflective of the history and culture of the municipality hence, strongly recommends that these be included in the PRECUP;


