WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled "A Resolution Authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to request financial assistance from Honorable Senator Risa Hontiveros for the implementation of the repair and improvement of the Multi-Purpose Covered Gym in Barangay Poblacion II in the Municipality of Marilao, Province of Bulacan, with a total project cost of Fifteen Million Pesos (₱15,000,000.00)," for appropriate action;

WHEREAS, the Municipality of Marilao, Bulacan, continuously seeks to improve its public services, local infrastructure, and overall community development for the welfare and benefit of its constituents;

WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, recognizes the urgent need for additional funding to undertake the repair and improvement of the Multi-Purpose Covered Gym in Barangay Poblacion II, which serves as an essential facility for various public, social, and community activities;

WHEREAS, Honorable Senator Risa Hontiveros has consistently extended support to Local Government Units (LGUs) in implementing infrastructure and community development projects that promote public welfare;

WHEREAS, Section 22 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991," empowers LGUs to enter into agreements and seek financial support from the national government, private sector, and other sources for the effective implementation of development projects;

WHEREAS, the Municipality of Marilao has identified the repair and improvement of the Multi-Purpose Covered Gym in Barangay Poblacion II as a priority development project, with a total estimated project cost of Fifteen Million Pesos (₱15,000,000.00);

WHEREAS, it is proper, necessary, and beneficial to authorize the Municipal Mayor, Honorable Atty. Jemina M. Sy, to formally request financial assistance from Honorable Senator Risa Hontiveros to ensure the timely, efficient, and successful implementation of the said project;

NOW THEREFORE, on motion of Councilor Juanito H. Santiago, duly seconded by Councilor Maria Luisa I. Silvestre, and upon unanimous vote of the Sangguniang Bayan members present:

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Sangguniang Bayan of Marilao, Bulacan, hereby authorizes the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to request financial assistance from Honorable Senator Risa Hontiveros for the implementation of the repair and improvement of the Multi-Purpose Covered Gym in Barangay Poblacion II, Municipality of Marilao, Province of Bulacan.

RESOLVED FURTHER, that the Municipal Mayor is hereby authorized to sign all necessary documents, communications, and correspondences in relation to the said request for financial assistance.

RESOLVED FINALLY, that copies of this Resolution be furnished to the Office of the Municipal Mayor, the Office of the Municipal Budget Officer, and the Office of the Municipal Treasurer for their information, guidance, and appropriate action.


