**A RESOLUTION RECOGNIZING THE OFFICIAL LIST OF IDENTIFIED HERITAGE  
AND CULTURAL SITES IN THE MUNICIPALITY OF MARILAO, AS PREPARED AND  
CERTIFIED BY THE MARILAO TOURISM SECTION**

**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a First Endorsement Letter entitled, "A Resolution Recognizing the Official List of Identified Heritage and Cultural Sites in the Municipality of Marilao, as prepared and certified by the Marilao Tourism Section." for appropriate action;

**WHEREAS**, Section 2 of Republic Act No. 10066, otherwise known as the National Cultural Heritage Act of 2009, mandates the protection, preservation, conservation, and promotion of the nation's cultural heritage, its properties and histories, and the cultural identity of local communities. Furthermore, Sections 14(b) and 14(c) of the said Act require Local Government Units (LGUs) to establish and maintain an inventory of cultural properties, while Section 16 directs LGUs to document and preserve traditional and contemporary arts within their jurisdiction;

**WHEREAS**, in compliance with said mandate, the Marilao Tourism Section has identified, prepared, and certified the following as the **Official List of Heritage and Cultural Sites in the Municipality of Marilao**, along with their respective years of establishment:

1. **Simbahan ng Bisitang Matanda** – 1588
2. **St. Michael the Archangel Parish Church (Marilao Church)** – 1796
3. **Bahay na Bato ng mga Villarica** – 1890
4. **Marilao Central Integrated School (Gabaldon Building)** – 1920
5. **Madre de la Divina Gracia de Marilao** – 1932
6. **Simbahan ng Bisitang Mahal na Señor ng Nagbalon** – 1947
