**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. ATTY. JEMINA M. SY FOR AND ON BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE MARILAO SAINT MICHAEL FAMILY HOSPITAL INC., REPRESENTED BY ITS MEDICAL DIRECTOR VENERANDA A. GEMARINO M.D., FOR THE REFERRAL OF DIAGNOSTIC SERVICES (CBC, CHEST X-RAY, FECALYSIS, AND LIPID PROFILE) IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.**

**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a First Endorsement Letter entitled, "A Resolution authorizing the Municipal Mayor Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with the Marilao St. Michael Hospital, represented by its Medical Director, Veneranda A. Geronimo, M.D., for the referral of Diagnostic Services (CBC, Chest X-ray, Fecalysis, and Lipid Profile) in the Municipality of Marilao, Province of Bulacan." for appropriate action;


**RESOLVED FURTHER**, that a copy of this Resolution be furnished to the Municipal Mayor and all other concerned offices for their information and appropriate action.
