**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE ATTY. JEMINA M. SY, FOR AND ON BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, TO ENTER INTO AND SIGN THE PERFORMANCE COMMITMENT FOR HEALTH FACILITIES (HFs) OF THE MARILAO RURAL HEALTH UNIT, IN COMPLIANCE WITH THE REQUIREMENTS OF THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH).**

**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a First Endorsement Letter entitled, "A Resolution authorizing the Municipal Mayor Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign the Performance Commitment for Health Facilities (HFs) of the Marilao Rural Health Unit, in compliance to the requirements of Philippine Health Insurance Corporation." for appropriate action;

**WHEREAS**, the Philippine Health Insurance Corporation (PhilHealth) requires all accredited health facilities to execute a Performance Commitment as part of its accreditation and continued participation in the National Health Insurance Program;

**WHEREAS**, the Marilao Rural Health Unit (RHU) is a government health facility providing essential health services to the constituents of the Municipality of Marilao;
