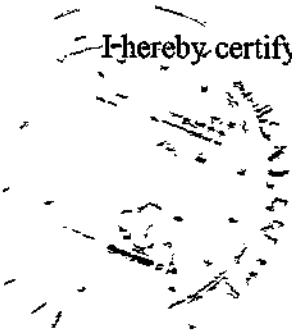

RESOLVED FURTHER, that a copy of this resolution be furnished to the Municipal Mayor and all other concerned parties for their information and appropriate action.

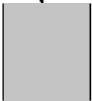
