**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to the Sangguniang Bayan a First Endorsement Letter entitled "*A Resolution approving and adopting MDC Resolution No. 2025-08 'A Resolution approving the Farm-To-Market Road Network Plan (FMRNP) 2025-2028 of the Municipality of Marilao, Province of Bulacan'*" for appropriate action;

**WHEREAS**, Section 106 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates every local government unit (LGU) to organize a Local Development Council at the provincial, city, municipal, or barangay level, which shall assist the corresponding Sanggunian in setting the direction of economic and social development and in coordinating development efforts within its territorial jurisdiction;

**WHEREAS**, the Municipal Development Council (MDC) prepared the Farm-to-Market Road Network Plan (FMRNP) 2025-2028 for the Municipality of Marilao, Province of Bulacan, which presents the inventory, prioritization, and implementation framework for farm-to-market road openings, rehabilitation, concreting, and maintenance for Calendar Years 2025 to 2028, aimed at enhancing agricultural productivity, improving connectivity from production areas to markets, and supporting food security and local economic growth;
