**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a First Endorsement Letter entitled, "A Resolution authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and in behalf of the Municipal Government of Marilao, to enter into and sign the Memorandum of Agreement (MOA) with Joni Villanueva General Hospital, for the establishment of referral linkages and designation of said hospital as Apex/End-referral Hospital under the Universal Health Care Act and pertinent Department of Health (DOH) issuances." for appropriate action;

**WHEREAS**, Section 22 (a) (5) and (c) of the Implementing Rules and Regulations of the Local Government Code states that a Local Government Unit as a corporation shall have the power to enter into contracts provided that it is authorized by the Local Sanggunian;

**WHEREAS**, Section V.E of Administrative Order (AO) 2020-00191 "Guidelines on the Service Delivery Design of Health Care Provider Networks" mandates all health care provider networks (HCPN) to have primary to tertiary care providers with linkages to an apex hospital and other facilities providing specialized services needed by its catchment population;

**WHEREAS**, Section VI.D.1.e of the said AO requires HCPNs to enter into Memorandum of Agreement with at least one apex hospital;

**WHEREAS**, upon scrutiny on the Memorandum of Agreement (MOA), this Body finds the provisions of the Memorandum of Agreement (MOA) in order and within the bounds of law;

**WHEREAS**, the Joni Villanueva General Hospital has been designated by the Department of Health as an apex or end referral hospital to provide specialized services that are not expected to be provided in HCPNs;

**WHEREAS**, the Municipality of Marilao is an HCPN that is compliant with AO 2020-0019 and wishes to link with the Joni Villanueva General Hospital as its Referral hospital;

**NOW, THEREFORE**, on motion of Hon. Wilfredo D. Diaz, duly seconded by Hon. Juanito H. Santiago, and upon unanimous vote of the members of the Sangguniang Bayan present:

**BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to authorize the Municipal Mayor Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with Joni Villanueva General Hospital, for the establishment of referral linkages and designation of said hospital as Apex/End-referral Hospital under the Universal Health Care Act and pertinent Department of Health (DOH) issuances."


**RESOLVED FURTHER**, that a copy of this Resolution be furnished to the Municipal Mayor and all other concerned offices for their information and appropriate action.
