A RESOLUTION RESPECTFULLY REQUESTING ENGR. GEORGE DC. SANTOS, DISTRICT ENGINEER OF BULACAN 2ND DISTRICT ENGINEER OFFICE, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), TO FUND THE CONSTRUCTION OF A BOX CULVERT WITH MINI PUMPING STATION ALONG MASIGASIG STREET, PUROK 1, IBAYO, MARILAO, BULACAN.

WHEREAS, Barangay Chairman of Barangay Ibayo presented to this August Body a letter, requesting the Sangguniang Bayan to enact or formulate a Resolution requesting Engr. George DC. Santos, District Engineer of Bulacan 2nd District Engineering's Office-DPWH, to fund the construction of a box culvert with mini pumping station along Masigasig St. Purok 1, Ibayo, Marilao, Bulacan.

WHEREAS, Masigasig Street, Purok 1, Barangay Ibayo, Municipality of Marilao, Bulacan, is a low-lying area that is frequently affected by flooding, especially during heavy rains and high tide;

WHEREAS, the existing drainage system along Masigasig Street is inadequate to efficiently carry floodwaters, causing prolonged inundation that disrupts daily activities and poses risks to public safety, health, and property;

WHEREAS, the construction of a **box culvert with a mini pumping station** will significantly improve water flow, prevent backflow, and mitigate flooding in the area, thereby enhancing the quality of life of the residents;

WHEREAS, the Department of Public Works and Highways (DPWH), through the Bulacan 2nd District Engineering Office, is the appropriate national government agency mandated to implement flood control and drainage infrastructure projects;

WHEREAS, Engr. George DC. Santos, as District Engineer of DPWH Bulacan 2nd District Engineering Office, plays a vital role in evaluating, prioritizing, and endorsing infrastructure projects that address urgent community needs;
