**RESOLUTION AUTHORIZING THE EXTENSION OF THE APPLICATION AND
RENEWAL PERIOD FOR MAYOR'S PERMITS / BUSINESS PERMITS IN THE
MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN UNTIL FEBRUARY 20,
2026.**

WHEREAS, the Office of the Mayor presented to this August Body a Letter of Endorsement entitled "Resolution Authorizing the extension of the application and renewal period for Mayor's Permits / Business Permits in the Municipality of Marilao, Province of Bulacan Until February 20, 2026. for appropriate action;

WHEREAS, Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, grants local government units the authority to regulate businesses operating within their territorial jurisdiction and to issue Mayor's Permits or Business Permits as a prerequisite to lawful business operation;

WHEREAS, the Municipality of Marilao requires all business establishments to apply for and renew their Mayor's Permits / Business Permits annually within the prescribed period;

WHEREAS, several business owners and operators have requested additional time to comply with the application and renewal requirements due to operational, administrative, and other valid concerns;

WHEREAS, granting an extension will promote compliance, avoid undue penalties, and support local businesses while ensuring continued regulation and monitoring by the Municipal Government;

WHEREAS, the extension of the application and renewal period is deemed beneficial to both the business sector and the Municipality of Marilao;

NOW, THEREFORE, on motion of Hon. Mary Del Jasa-Aquino, duly seconded by Hon. Harvey C. Mediante, and upon unanimous vote of the members of the Sangguniang Bayan present:

BE IT RESOLVED, as it is hereby **RESOLVED**, to AUTHORIZE THE EXTENSION OF THE APPLICATION AND RENEWAL PERIOD FOR MAYOR'S PERMITS / BUSINESS PERMITS IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN UNTIL FEBRUARY 20, 2026, without the imposition of penalties within the extended period;

RESOLVED, FURTHER, that the Office of the Municipal Mayor, the Business Permits and Licensing Office (BPLO), and all concerned municipal offices are hereby directed to implement this Resolution and to give proper notice to all affected business establishments;

RESOLVED, FINALLY, that copies of this Resolution be furnished to all concerned offices for their information, guidance, and compliance.
