A RESOLUTION EARNESTLY REQUESTING THE HONORABLE PROVINCIAL GOVERNOR, HON. DANIEL R. FERNANDO, THROUGH ENGR. GLEN D. REYES, PROVINCIAL ENGINEER OF BULACAN, TO ALLOCATE FUNDS FOR THE ROAD CONCRETING AND ROAD WIDENING ALONG M. VILLARICA ROAD, MUNICIPALITY OF MARILAO, BULACAN

WHEREAS, M. Villarica Road in the Municipality of Marilao is a vital thoroughfare used daily by residents, commuters, and commercial vehicles;

WHEREAS, the existing condition of the road and the limited right-of-way along certain portions of M. Villarica Road contribute to traffic congestion, safety hazards, and difficulty in the smooth flow of vehicles and pedestrians;

WHEREAS, several residents along M. Villarica Road have voluntarily agreed to provide road setbacks to allow the widening of the road for the common good;

WHEREAS, the proposed road widening and concreting project along M. Villarica Road is intended to improve accessibility, traffic management, and public safety for the benefit of the general public;

WHEREAS, the implementation of the said project requires substantial funding and technical assistance which may be provided by the Provincial Government of Bulacan through the Office of the Provincial Engineer;

Reyes**, Provincial Engineer of Bulacan, to allocate funds for the **road concreting and road widening** along **M. Villarica Road**, Municipality of Marilao, Bulacan.


RESOLVED, FURTHER, that copies of this Resolution be furnished to all concerned offices for their information, guidance, and compliance.
