WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a First Endorsement Letter entitled, "A Resolution authorizing the Municipal Mayor, Hon. Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with Department of Education (DepEd) for the implementation, transfer and utilization of funds for School Building Projects under the GAA 2026 Basic Education Facilities Program in the Municipality of Marilao, Province of Bulacan." for appropriate action,

WHEREAS, the 2026 General Appropriations Act (GAA) provides funding under the Basic Education Facilities Program (BEFP) for the construction, rehabilitation, and improvement of public school facilities nationwide;

WHEREAS, the Department of Education (DepEd) implements the Basic Education Facilities Program to address classroom shortages and improve the learning environment of public schools;

WHEREAS, the Municipality of Marilao has been identified as a beneficiary of the School Building Projects under the GAA 2026 Basic Education Facilities Program;

WHEREAS, the implementation of said projects requires the execution of a Memorandum of Agreement (MOA) between the Department of Education and the Municipal Government of Marilao for the proper implementation, transfer, and utilization of funds;

WHEREAS, there is a need to authorize the Municipal Mayor, Hon. Atty. Jemina M. Sy, to represent the Municipal Government of Marilao in entering into and signing the said MOA with the Department of Education;

NOW, THEREFORE, on motion of Hon. Vanessa Valdez-Seminiano, duly seconded by Hon. Juanito H. Santiago, and upon unanimous vote of the members of the Sangguniang Bayan present:

BE IT RESOLVED, as it is hereby **RESOLVED**, to authorize the Municipal Mayor, **Hon. Atty. Jemina M. Sy**, for and on behalf of the Municipal Government of Marilao, to enter into and sign a **Memorandum of Agreement (MOA)** with the **Department of Education (DepEd)** for the implementation, transfer, and utilization of funds for **School Building Projects under the GAA 2026 Basic Education Facilities Program** in the Municipality of Marilao, Province of Bulacan;

RESOLVED FURTHER, that the Municipal Mayor is likewise authorized to sign all documents and undertake all actions necessary for the effective implementation of the said program, subject to existing laws, rules, and regulations;

RESOLVED FINALLY, that copies of this Resolution be furnished to the Department of Education and other concerned offices for their information and appropriate action.


RESOLVED, FURTHER, that copies of this Resolution be furnished to all concerned offices for their information, guidance, and compliance.
