**AN ORDINANCE PROVIDING A TEACHERS' SCHOLARSHIP PROGRAM FOR  
PUBLIC SCHOOLS IN THE MUNICIPALITY OF MARILAO, PROVINCE OF  
BULACAN, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES.**

**WHEREAS**, the Department of Education recognizes and appreciates partnerships and initiatives aimed at upgrading the academic qualifications, values, and skills of public school teachers through funded scholarship grants;

**WHEREAS**, the Municipality of Marilao is committed to supporting projects and activities designed to improve the quality of education in public schools by enhancing the knowledge, attitudes, and skills of its teachers;

**WHEREAS**, to realize this goal, it is necessary to engage with accredited state tertiary institutions committed to training highly qualified and dedicated teachers, who are vital to promoting quality education geared toward social transformation;

**WHEREAS**, the Municipality of Marilao aims to promote the welfare of its teachers by providing scholarships that will enable them to pursue career growth and professional development;

**NOW, THEREFORE**, on motion of Honorable Juanito H. Santiago, duly seconded by Honorable Wilfredo D. Diaz, and upon unanimous vote,

**REGULAR SESSION

**BE IT ORDAINED** by the Sangguniang Bayan of Marilao, Bulacan, in session assembled, that:

**SECTION 1. TITLE.** This Ordinance shall be known as “The Teachers’ Scholarship Program for Public Schools in the Municipality of Marilao, Province of Bulacan;”

**SECTION 2. DECLARATION OF POLICY.** It is hereby declared the policy of the Municipality of Marilao to improve the quality of education in public schools through the continuous upgrading of the knowledge, attitudes, and skills of its teachers;

**SECTION 3. QUALIFICATIONS OF SCHOLARS.** Applicants must be personnel of public basic education institutions within the Municipality of Marilao and must satisfy the requirements set by the Department of Education, as well as any additional qualifications that may be prescribed by the Office of the Municipal Mayor;

**SECTION 4. SCHOLARSHIP SLOTS.** The number of scholarship slots shall be subject to the availability of funds allocated under the Teachers’ Scholarship Program;

**SECTION 5. DEGREE-GRANTING INSTITUTION.** For the purpose of this Ordinance, the Municipality shall enter into a Memorandum of Agreement (MOA) with the Department of Education – Schools Division Office and partner institutions that are recognized State Higher Education Institutions (HEIs) offering graduate-level programs. Among the terms and conditions of the MOA shall be the responsibility of the HEI to oversee the overall administration and management of the program and to submit regular progress and terminal reports to the Office of the Mayor and the DepEd Schools Division Office of Marilao;

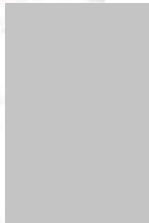
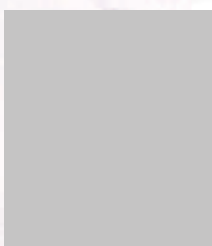
**SECTION 6. APPROPRIATION.** An initial amount of **Two Million Pesos (₱2,000,000.00)** shall be appropriated for the implementation of this Ordinance and shall be included in the Annual Budget of the Municipality in subsequent fiscal years;

**SECTION 7. IMPLEMENTING RULES AND REGULATIONS (IRR).** The Office of the Municipal Mayor shall formulate and issue the necessary Implementing Rules and Regulations (IRR) for the effective implementation of this Ordinance within sixty (60) days from its approval;

**SECTION 8. SEPARABILITY CLAUSE.** If, for any reason, any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall remain in full force and effect;

**SECTION 9. REPEALING CLAUSE.** All ordinances, resolutions, executive orders, rules and regulations, or parts thereof that are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;


**SECTION 10. EFFECTIVITY.** This Ordinance shall take effect fifteen (15) days after its posting in at least three (3) conspicuous places within the Municipality of Marilao and publication in a newspaper of general circulation, in accordance with existing laws and regulations;




