AN ORDINANCE PROVIDING A MORATORIUM AND SUSPENDING THE ASSESSMENT AND COLLECTION OF MUNICIPAL TRICYCLE FRANCHISING PERMIT FEES FOR TRICYCLE OPERATORS AND DRIVERS UNDER ARTICLE G, SECTION 3G.02 OF MUNICIPAL ORDINANCE NO. 1058, C.Y. 2024, OTHERWISE KNOWN AS "AN ORDINANCE PROVIDING FOR THE REVISION OF THE REVENUE CODE OF THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN."

WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy presented to this August Body a Letter of Endorsement entitled "*An Ordinance providing for a moratorium and suspending the assessment and collection of Municipal Tricycle Franchising Permit Fees for Tricycle Operators and Drivers under Article G, Section 3G.02 of the Municipal Ordinance No. 1058 C.Y. 2024, also known as "An Ordinance providing the Revision of Revenue Code in the Municipality of Marilao, Province of Bulacan."* for appropriate action;

WHEREAS, the Municipality of Marilao recognizes the vital role of tricycle operators and drivers in providing accessible and affordable transportation services to the public, particularly within barangays and interior roads;

WHEREAS, Municipal Ordinance No. 1058, C.Y. 2024, otherwise known as the Revised Revenue Code of the Municipality of Marilao, imposes Municipal Tricycle Franchising Permit Fees under Article G, Section 3G.02 thereof;

WHEREAS, tricycle operators and drivers continue to face economic challenges brought about by rising fuel costs, increasing maintenance expenses, and other financial constraints affecting their livelihood;

WHEREAS, there is a need to provide temporary financial relief to tricycle operators and drivers to help sustain their operations and ensure the continued delivery of essential public transport services in the Municipality;

WHEREAS, the Sangguniang Bayan deems it just and equitable to provide a moratorium and suspend the assessment and collection of the said fees for a limited period in the interest of public welfare;

NOW, THEREFORE, on motion of Hon. Vanessa Valdez-Seminiano duly seconded by Hon. Harvey C. Mediante, and upon unanimous vote of the members of the Sangguniang Bayan present:

BE IT ORDAINED by the Sangguniang Bayan of the Municipality of Marilao, Province of Bulacan, in session assembled, that:

SECTION 1. TITLE - This Ordinance shall be known as "An Ordinance providing a Moratorium and Suspending the Assessment and Collection of Municipal Tricycle Franchising Permit Fees."

SECTION 2. COVERAGE - This Ordinance shall apply to all duly registered tricycle operators and drivers operating within the territorial jurisdiction of the Municipality of Marilao who are subject to the payment of Municipal Tricycle Franchising Permit Fees under Article G, Section 3G.02 of Municipal Ordinance No. 1058, C.Y. 2024.

SECTION 3. MORATORIUM AND SUSPENSION OF FEES. A moratorium is hereby declared, and the assessment and collection of Municipal Tricycle Franchising Permit Fees imposed under Article G, Section 3G.02 of Municipal Ordinance No. 1058, C.Y. 2024, are hereby suspended for a period of **Five (5) years**.

SECTION 4. NON-REFUNDABILITY. All Municipal Tricycle Franchising Permit Fees paid prior to the effectivity of this Ordinance shall not be subject to refund.

SECTION 5. IMPLEMENTING OFFICES. The Municipal Treasurer's Office, Business Permit and Licensing Office, and all other concerned offices are hereby directed to implement the provisions of this Ordinance accordingly.

SECTION 6. REPEALING CLAUSE. All ordinances, resolutions, rules, and regulations, or parts thereof, inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall remain in full force and effect.

SECTION 8. EFFECTIVITY. This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of local circulation or after posting in conspicuous places within the Municipality, as required by law.
