



WHEREAS, in Section 34 of the Local Government Code of 1991 (Republic Act No. 7160) support the creation and operation of people's organizations (POs) and non-governmental organizations (NGOs) in the promotion of local autonomy;

WHEREAS, Article 62, Rule XIII of the Implementing Rules and Regulations (IRR) of Local Government Code 1991 strengthens the aforementioned provision, emphasizing that NGOs and POs should be included in the planning and execution of local government projects and activities, participate in local special bodies, and assist in the delivery of public services;
