



WHEREAS, Honorable Atty Iemina M Sy presented to this August Body a First Endorsement Letter entitled "*Resolution approving the Comprehensive Local Juvenile Intervention Program for the Calendar Year 2025 in the Municipality of Marilao, Province of Bulacan.*" for its appropriate action;

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 mandates all Local Governments to promote the general welfare of their inhabitants, provide basic services for their constituents which shall ensure the effective and efficient delivery of such services;

WHEREAS, the Juvenile and Welfare Council created by virtue of Republic Act 9344 provides the Comprehensive National Juvenile Intervention Program framework to ensure the efficient implementation and to serve as guide for LGU's in the preparation of their intervention and diversion programs for Children in Conflict with the Law;

WHEREAS, Section 18, of Republic Act No. 9344 requires LGUs to develop a Comprehensive Juvenile Intervention Program;

WHEREAS, The Municipal Juvenile Intervention Program will help achieve goal of reducing crimes committed by children and those committed against them and also it will look after the children's welfare and avert the young people to commit infractions and undesirable acts;
