**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled "A Resolution Authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to request financial assistance from **Honorable Senator Joseph Victor "JV" G. Ejercito** for the implementation of Marilao River Pumping Station Project in Barangay Nagbalon and Barangay Ibayo, Marilao, Bulacan, with a total project cost of Two Hundred Thirty Million Pesos (P230,000,000.00)" for appropriate action;

**WHEREAS**, the proposed Marilao River Pumping Station Project aims to mitigate flooding, improve drainage capacity, and enhance disaster resilience in the affected barangays;

**WHEREAS**, the Municipality of Marilao, Bulacan continuously seeks ways to improve its public services, local infrastructure, and overall development for the welfare of its constituents;

**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy, recognizes the need for additional funding to implement priority development projects within the Municipality;

**WHEREAS**, Honorable Senator Joseph Victor "JV" G. Ejercito has consistently extended support to local government units for the implementation of projects that enhance public services and community development;

**WHEREAS**, Section 22 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers Local Government Units to enter into agreements and seek financial assistance from the national government, private sector, and other sources for the implementation of development projects;

**WHEREAS**, the total project cost for the implementation of the Marilao River Pumping Station Project is estimated at Two Hundred Thirty Million Pesos (P230,000,000.00);

**WHEREAS**, it is proper and necessary to authorize the Municipal Mayor, Honorable Atty. Jemina M. Sy, to formally request financial assistance from Honorable Senator Joseph Victor "JV" G. Ejercito to ensure the timely and effective implementation of the said project;

**NOW THEREFORE**, on motion of Councilor Vanessa Valdez-Seminiano, duly seconded by Councilor Maria Luisa I. Silvestre, and upon unanimous vote;

**BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that the Sangguniang Bayan of Marilao, Bulacan hereby authorizes the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to request financial assistance from Honorable Senator Joseph Victor "JV" G. Ejercito for the implementation of the Marilao River Pumping Station Project in Barangay Nagbalon and Barangay Ibayo, Marilao, Bulacan, with a total project cost of Two Hundred Thirty Million Pesos (P230,000,000.00);

**RESOLVED FURTHER**, that the Municipal Mayor is authorized to sign all necessary documents, communications, and correspondences related to this request for financial assistance;

**RESOLVED FINALLY**, that a copy of this resolution be furnished to the Municipal Mayor, and all other concerned parties for their information and appropriate action.
