WHEREAS, the project entitled "Construction of Marilao Port, Marilao, Bulacan" has been granted funding in the amount of Ten Million Pesos (P10,000,000.00) under the Fiscal Year 2026 General Appropriations Act;

WHEREAS, the implementation of the said project requires the signing and execution of contracts, agreements, certifications, and other pertinent documents necessary to facilitate the release of funds and commencement of project activities;

WHEREAS, it is necessary and proper to authorize the Municipal Mayor, Honorable Atty. Jemina M. Sy, to sign and execute all documents related to the implementation of the said project;
