WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled "*A Resolution authorizing the Municipal Mayor Hon. Atty. Jemina M. Sy, for and in behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with all Sixteen (16) Barangays of Marilao for the application and implementation of material recovery systems in the Municipality of Marilao, Province of Bulacan.*" for appropriate action;

WHEREAS, Section 16 of the Local Government Code of 1991 provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those essential to the promotion of the general welfare;

WHEREAS, Republic Act No. 9003, otherwise known as the Ecological Solid Waste Management Act of 2000, mandates the establishment of Material Recovery Facilities (MRFs) in every barangay or cluster of barangays to promote waste segregation, recycling, and resource recovery;

WHEREAS, the Municipality of Marilao recognizes the importance of strengthening solid waste management systems through coordinated efforts between the Municipal Government and its Sixteen (16) Barangays to ensure efficient implementation of material recovery systems;

WHEREAS, the proposed Memorandum of Agreement (MOA) between the Municipal Government of Marilao and the Sixteen (16) Barangays will define the roles, responsibilities, and commitments of each party in the establishment, operation, monitoring, and sustainability of material recovery systems;

NOW THEREFORE, on motion of Councilor Vanessa Valdez-Seminiano, duly seconded by Councilor Harvey C. Mediante, and upon unanimous vote;

BE IT RESOLVED, as it is hereby resolved, to authorize the Municipal Mayor, HON. ATTY. JEMINA M. SY, for and in behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with all Sixteen (16) Barangays of Marilao for the application and implementation of material recovery systems in the Municipality of Marilao, Province of Bulacan.


RESOLVED FURTHER, that a copy of this resolution be furnished to the Municipal Mayor, and all other concerned parties for their information and appropriate action.
