**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled "*A Resolution authorizing the Municipal Mayor Hon. Atty. Jemina M. Sy, for and in behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with G-Exchange, Inc., for the adoption of Gcash as an alternative mode of payment for Official transactions of the constituents with the Municipal Government of Marilao, Province of Bulacan.*" for appropriate action;

**WHEREAS**, Republic Act No. 11032, otherwise known as the *Ease of Doing Business and Efficient Government Service Delivery Act of 2018*, encourages the adoption of digital technologies to streamline processes, reduce red tape, and improve efficiency in government services;

**WHEREAS**, Republic Act No. 8792, otherwise known as the *Electronic Commerce Act of 2000*, recognizes the legal validity of electronic documents, electronic data messages, and electronic signatures in government and commercial transactions;

**WHEREAS**, the Municipal Government of Marilao is committed to improving the delivery of public service through efficient, transparent, and technology-driven systems;

**WHEREAS**, the adoption of digital payment platforms enhances convenience, promotes financial inclusion, and ensures faster and more secure transactions between the local government and its constituents;

**WHEREAS**, G-Exchange, Inc. (GXI), the operator of GCash, provides digital financial services that enable secure electronic payments for government transactions;

**WHEREAS**, the implementation of GCash as an alternative mode of payment will provide constituents with a more accessible and convenient option for paying taxes, fees, and other official charges due to the Municipal Government;

**WHEREAS**, the integration of digital payment systems supports the Municipal Government's goal of a business-friendly environment, and promotes financial inclusion for constituents, including the unbanked sector;

**NOW THEREFORE**, on motion of Councilor Vanessa Valdez-Seminiano, duly seconded by Councilor Juanito H. Santiago, and upon unanimous vote;

**RESOLVED**, as it is hereby resolved, to authorize the Municipal Mayor, Hon. Atty. Jemina M. Sy, for and in behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with G-Exchange, Inc., for the adoption of GCash as an alternative mode of payment for official transactions of the constituents with the Municipal Government of Marilao, Province of Bulacan;


**RESOLVED FURTHER**, that a copy of this Resolution be furnished to G-Exchange, Inc. and other concerned offices for their information and appropriate action.
