WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled "*A Resolution authorizing the Municipal Mayor Hon. Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with Fast Health Diagnostic and Medical Clinic as an accredited drug testing clinic of the Municipal Government of Marilao, Province of Bulacan.*" for appropriate action;

WHEREAS, the Municipal Government of Marilao is committed to promoting a drug-free workplace and ensuring the health, safety, and welfare of its employees;

WHEREAS, in line with the policies of the government and relevant regulations of the Civil Service Commission and other concerned agencies regarding drug-free workplaces, the Municipal Government thru its Human Resource and Management Office and Health Office assist to drug testing for its personnel;

WHEREAS, **Fast Health Diagnostic and Medical Clinic** is a licensed and qualified medical facility capable of providing reliable and accurate drug testing services;

WHEREAS, it is necessary to enter into a Memorandum of Agreement with Fast Health Diagnostic and Medical Clinic to formally designate it as an accredited drug testing clinic of the Municipal Government of Marilao;
