WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled "*A Resolution approving the annual work and financial plan for LCAT-VAWC for the Calendar Year 2026 of the Local Government Unit of Marilao, amounting to One Million Two Hundred Thirty-Two Thousand Pesos (P1,232,000.00).*" for appropriate action;

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 mandates all Local Governments to promote the general welfare of their inhabitants, provide basic services for their constituents which shall ensure the effective and efficient delivery of such services;

WHEREAS, the State recognizes the role of women in nation-building and ensures the fundamental equality before the law of women and men;

WHEREAS, Republic Act No. 9262, otherwise known as the *Anti-Violence Against Women and Their Children Act of 2004*, mandates local government units to implement programs, services, and interventions to address violence against women and their children;

WHEREAS, Republic Act No. 9208, otherwise known as the *Anti-Trafficking in Persons Act of 2003*, as amended by Republic Act No. 10364 or the *Expanded Anti-Trafficking in Persons Act of 2012*, requires the strengthening of mechanisms at the local level to prevent trafficking in persons and protect victims;

WHEREAS, Republic Act No. 9710, otherwise known as the *Magna Carta of Women*, mandates government agencies and local government units to formulate and implement programs addressing gender-based violence and to allocate funds for gender and development (GAD) programs;

WHEREAS, Joint Memorandum Circular No. 2010-1 issued by the Department of the Interior and Local Government (DILG), Department of Social Welfare and Development (DSWD), and Philippine Commission on Women (PCW) encourages local government units to establish and strengthen Local Committees on Anti-Trafficking and Violence Against Women and Their Children (LCAT-VAWC) as mechanisms for coordination and implementation of programs;

WHEREAS, the Local Committee Against Trafficking and Violence Against Women and Their Children (LCAT-VAWC) of the Municipality of Marilao has prepared its Annual Work and Financial Plan for Calendar Year 2026 to strengthen the implementation of programs, projects, and activities related to prevention, protection, recovery, and reintegration of victims;

WHEREAS, the implementation of the said plan requires financial support from the Local Government Unit of Marilao in the total amount of One Million Two Hundred Thirty-Two Thousand Pesos (₱1,232,000.00);

NOW THEREFORE, on motion of Councilor Maria Luisa I. Silvestre, duly seconded by Councilor Juanito H. Santiago, and upon unanimous vote;

BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Marilao, Bulacan, in session assembled, to approve the Annual Work and Financial Plan (AWFP) of the Local Committee Against Trafficking and Violence Against Women and Their Children (LCAT-VAWC) for Calendar Year 2026, in the total amount of One Million Two Hundred Thirty-Two Thousand Pesos (₱1,232,000.00).
