WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled "*A Resolution authorizing the Municipal Mayor, Hon. Atty. Jemina M. Sy, to extend the contract for security services with Escort Security Services, Inc., and Crime Preventor Security Services, Inc., until March 31, 2026, subject to all the terms and conditions stipulated therein.*" for appropriate action;

WHEREAS, the Municipality entered into a contract with **Escort Security Services, Inc., and Crime Preventor Security Services, Inc.**, for the provision of security services to various municipal offices and facilities;

WHEREAS, the existing contract is set to expire, and there is a continuing need for uninterrupted security services to ensure the safety and protection of government personnel, properties, and the general public;

WHEREAS, the extension of the contract with **Escort Security Services, Inc., and Crime Preventor Security Services, Inc.**, is deemed necessary and beneficial to the Municipality, pending the completion of procurement requirements for a new contract;
