**A RESOLUTION REQUESTING THE HONORABLE SENATOR SHERWIN T. GATCHALIAN FOR FINANCIAL ASSISTANCE FOR THE REHABILITATION OF THE FARM-TO-MARKET ROAD BESIDE NLEX ALONG THE MARILAO SERVICE ROAD, WITH AN ESTIMATED PROJECT COST OF ₱24,170,550.00, LOCATED IN BARANGAY PATUBIG, MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.**

**WHEREAS**, the Municipal Mayor, Honorable Atty. Jemina M. Sy, submitted to this August Body a Letter of Endorsement entitled "*A Resolution requesting the Honorable Senator Sherwin T. Gatchalian for Financial Assistance for the rehabilitation of the Farm-to-Market Road beside NLEX along the Marilao Service Road, with an estimated project cost of ₱24,170,550.00, located in Barangay Patubig, Municipality of Marilao, Province of Bulacan.*" for appropriate action;

**WHEREAS**, the Municipal Government of Marilao recognizes the importance of easy accessing road for residents, farmers, and motorist in the area;

**WHEREAS**, the farm-to-market road beside the NLEX along the Marilao Service Road located in Barangay Patubig serves as an essential access route for residents, farmers, and transport vehicles transporting agricultural products to nearby markets and commercial areas;

**WHEREAS**, the said road is presently in deteriorated condition, causing inconvenience, delays in transportation, and potential safety hazards to motorists, farmers, and residents of the barangay;

**WHEREAS**, the rehabilitation and improvement of this road will significantly enhance the mobility of agricultural goods, improve access for the motorist, and contribute to the overall development of the Municipality of Marilao;

**WHEREAS**, the Barangay Government of Patubig does not have sufficient financial resources to undertake the rehabilitation project with an estimated cost of ₱24,170,550.00;

**WHEREAS**, the office of Senator Sherwin T. Gatchalian has been actively supporting infrastructure and community development projects that improve local accessibility and economic opportunities;

**NOW, THEREFORE**, on motion of Hon. Vanessa Valdez-Seminiano, duly seconded by Hon. Juanito H. Santiago, and upon unanimous vote of the members of the Sangguniang Bayan present:

**BE IT RESOLVED**, as it is hereby **RESOLVED**, to respectfully request the Honorable Senator Sherwin T. Gatchalian to provide financial assistance for the rehabilitation of the farm-to-market road beside NLEX along the Marilao Service Road, located in Barangay Patubig, Municipality of Marilao, Province of Bulacan, with an estimated project cost of ₱24,170,550.00.
