WHEREAS, the Municipal Mayor, Honorable Atty. Jemina M. Sy, presented to this August Body a Letter of Endorsement entitled: *"A Resolution Authorizing the Municipal Mayor Hon. Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) Field Office III, represented by Dir. Venus F. Rebuldelela, and Pambayang Dalubhasaan ng Marilao represented by its School Administrator, Dolores D. Cajucom, for the application and implementation of the Tara, Basa! Tutoring Program in the Municipality of Marilao, Province of Bulacan,"* for appropriate action;

WHEREAS, the DSWD is the lead agency for social protection and is mandated to work towards improving the capacity and opportunities of poor, vulnerable, and disadvantaged individuals, families, and communities to attain a better quality of life, pursuant to the provisions of the *Social Welfare Act of 1968* and *Administrative Code of 1987*, as amended;

WHEREAS, the Department of Education (DepEd) is the lead agency in protecting and promoting the right of every Filipino to quality, equitable, culture-based, and complete basic education pursuant to the Governance of Basic Education Act of 2001;

WHEREAS, the DepEd formulates, implements, and coordinates policies, plans, programs, and projects in both formal and non-formal basic education, supervises all elementary and secondary education institutions, and ensures an adequate and integrated system of basic education aligned with national development goals;

WHEREAS, the DSWD, through its Social Technology Bureau, developed the "*Tara, Basa!*" Tutoring Program, a community-based social welfare and development intervention aimed at providing support to low-income families, college students in difficult circumstances, and elementary learners who are struggling or non-readers;

WHEREAS, the Program aims to promote and protect the well-being of individuals and families who are poor, vulnerable, or at risk;

WHEREAS, the "*Tara, Basa!*" Tutoring Program is implemented in identified areas by the DSWD in coordination with Local Social Welfare and Development Offices, School Division Offices, and State/Local Universities and Colleges (S/LUCs), thereby requiring convergence and cooperation among the parties;

NOW, THEREFORE, on motion of Honorable Vanessa Valdez-Seminiano, duly seconded by Honorable Juanito H. Santiago and upon unanimous vote.

BE IT RESOLVED, as it is hereby resolved, to authorize the Municipal Mayor, Hon. Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) Field Office III and Pambayang Dalubhasaan ng Marilao for the application and implementation of the "*Tara, Basa!*" Tutoring Program in the Municipality of Marilao, Province of Bulacan.
