WHEREAS, the Office of Honorable Senator Vicente "Tito" C. Sotto III extends financial assistance for local government projects that contribute to sustainable development and public welfare;

NOW THEREFORE, on motion of Councilor Vanessa Valdez-Seminiano, duly seconded by Councilor Juanito H. Santiago, and upon unanimous vote;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the Sangguniang Bayan of Marilao, Bulacan hereby authorizes the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to request financial assistance from Honorable Senator Vicente C. Sotto III for the implementation of Multi-Purpose Building Projects, namely a sports complex to established within the Municipality of Marilao and a school building at Pambayang Dalubhasaan ng Marilao (PDM), Province of Bulacan, with a total project cost of One Hundred Million Pesos (₱100,000,000.00);
