



A RESOLUTION GRANTING FUEL SUBSIDY TO REGISTERED TRICYCLE AND JEEPNEY DRIVERS IN THE MUNICIPALITY OF MARILAO, BULACAN.

WHEREAS, the Municipality of Marilao recognizes the vital role of tricycle and jeepney drivers in providing accessible and affordable transportation services to the public;

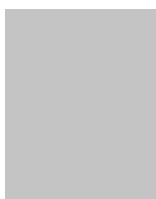
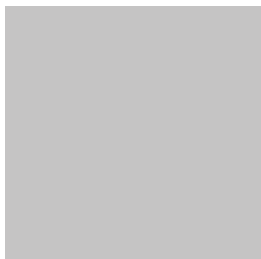
WHEREAS, the continuous increase in fuel prices has significantly affected the income and livelihood of public utility drivers, thereby impacting their ability to sustain daily operations;

WHEREAS, the recent conflicts and war in the Middle East, a major global source of petroleum, have contributed to the instability and increase in fuel prices in the international market, which directly affects local fuel costs;

WHEREAS, there is a need for the Local Government Unit of Marilao to extend financial assistance in the form of fuel subsidy to mitigate the adverse effects of rising fuel costs;

WHEREAS, providing a fuel subsidy will help ensure the continued operation of public transport services and support the welfare of drivers and their families;

NOW, THEREFORE, on motion of Honorable Harvey C. Mediante duly seconded by Honorable Wilfredo D. Diaz and upon unanimous vote:

RESOLVED FURTHER, that the subsidy shall be given to:

- a. Duly registered tricycle drivers under the Tricycle Operators and Drivers' Association (TODA);
- b. Registered jeepney drivers operating within or passing through Marilao, with valid franchises or permits;
- c. Drivers who are bona fide residents of Marilao, unless otherwise determined by the Local Government Unit;

RESOLVED FURTHER, that each qualified beneficiary shall receive a fuel subject to availability of funds and guidelines to be issued by the Municipal Government;


RESOLVED FINALLY, that copies of this Resolution be furnished to the concerned agencies for their information, guidance, and appropriate action.
