WHEREAS, the Municipal Mayor Honorable Jemina M. Sy presented to this August Body a Letter of Endorsement entitled: "*A Resolution authorizing the Municipal Mayor Hon. Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Understanding (MOU) with Marilao Eye Care Center, Bocaue Eye Clinic, and Meycauayan Eye Clinic for the application and implementation of no balance billing for eye and ear-nose-throat (EENT) care services to indigent constituents in the Municipality of Marilao, Province of Bulacan.*" for appropriate actions;

WHEREAS, the Municipality of Marilao is committed to promoting the health and well-being of its constituents, particularly indigent residents who have limited access to essential healthcare services;

WHEREAS, access to affordable and quality Eye and Ear-Nose-Throat (EENT) care remains a significant concern among marginalized sectors in the municipality;

WHEREAS, the implementation of a No Balance Billing Policy ensures that indigent patients are not charged any amount beyond what is covered under agreed healthcare arrangements;

WHEREAS, the Municipal Government of Marilao seeks to partner with reputable healthcare providers that strategically located at the Province of Bulacan such as Marilao Eye Care Center, Bocaue Eye Clinic, and Meycauayan Eye Clinic that offering consultations and treatments relating to EENT diseases;

WHEREAS, a Memorandum of Understanding (MOU) shall formalize the partnership, outlining the roles, responsibilities, and commitments of all parties involved in the implementation of the No Balance Billing program;

NOW, THEREFORE, on motion of Honorable Vanessa Valdez-Seminiano duly seconded by Honorable Wilfredo D. Diaz and upon unanimous vote:

BE IT RESOLVED, as it is hereby resolved, to authorize the Municipal Mayor Hon. Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Understanding (MOU) with Marilao Eye Care Center, Bocaue Eye Clinic, and Meycauayan Eye Clinic for the application and implementation of no balance billing for eye and ear-nose-throat (EENT) care services to indigent constituents in the Municipality of Marilao, Province of Bulacan.;


RESOLVED FURTHER, that copies of this Resolution be furnished to the concerned agencies for their information, guidance, and appropriate action.
