**WHEREAS**, the Municipal Mayor Honorable Jemina M. Sy presented to this August Body a Letter of Endorsement entitled: "*A Resolution Authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, enter into and sign a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) Field Office III, reperesented by Dir. Venus F. Rebuldela, for the application and implementation of the Milk Feeding Program (MFP) along with the Supplementary Feeding Program (SFP) in the Municipality of Marilao, Province of Bulacan.*" for appropriate actions;

**WHEREAS**, the Municipal Government of Marilao is committed to promoting the health, nutrition, and overall well-being of its constituents, particularly children belonging to vulnerable and underprivileged sectors;

**WHEREAS**, the Department of Social Welfare and Development (DSWD) implements programs such as the Milk Feeding Program (MFP) and the Supplementary Feeding Program (SFP) to address malnutrition among children;

**WHEREAS**, the Milk Feeding Program (MFP), in coordination with the Supplementary Feeding Program (SFP), aims to improve the nutritional status of children through the provision of milk and nutritious food supplements;

**WHEREAS**, SFP is the provision of food in addition to the regular targeting all children enrolled in public/LGU run Child Development Center (CDCs) and Supervised Neighborhood Play Groups (SNPs) two years old and above, pursuant to DSWD Memorandum Circular No. 26 series 2024;

**WHEREAS**, the Municipality of Marilao intends to collaborate with DSWD Field Office III to ensure the effective implementation of these programs at the local level;

**WHEREAS**, a Memorandum of Agreement (MOA) is necessary to formalize the partnership, defining the roles, responsibilities, and commitments of both parties;


**NOW, THEREFORE**, on motion of Honorable Vanessa Valdez-Seminiano duly seconded by Honorable Maria Luisa I. Silvestre and upon unanimous vote:

**BE IT RESOLVED**, as it is hereby resolved by the Sangguniang Bayan of Marilao, Bulacan, in session duly assembled, to authorize the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) Field Office III, represented by Director Venus F. Rebuldela, for the application and implementation of the Milk Feeding Program (MFP) in conjunction with the Supplementary Feeding Program (SFP).
