WHEREAS, the Municipal Mayor Honorable Atty. Jemina M. Sy presented to this August Body a Letter of Endorsement entitled: "*A Resolution Authorizing the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with the Bulacan Drug Rehabilitation Foundation, Inc. (BDRFI) for the application and implementation of a comprehensive drug prevention, treatment, rehabilitation, and aftercare framework in the Municipality of Marilao, Province of Bulacan.*" for appropriate actions;

WHEREAS, the Municipal Government of Marilao is committed to promoting the general welfare, safety, and well-being of its constituents, including the protection of individuals and families from the harmful effects of illegal drug use and abuse;

WHEREAS, illegal drug use remains a significant concern that adversely affects public health, safety, and socio-economic development in the Municipality;

WHEREAS, there is a need to adopt a holistic and sustainable approach that includes prevention, treatment, rehabilitation, and aftercare services to effectively address substance abuse and dependency;

WHEREAS, the Municipality of Marilao has established its Municipal Anti-Drug Abuse Council (MADAC), which serves as the central coordinating body for assessment, endorsement, referral, monitoring, and aftercare of drug users and persons with substance-related concerns;

WHEREAS, currently, the Municipality of Marilao does not have an in-house Drug Dependency Examination (DDE) Doctor, thereby requiring the services of a DOH-accredited facility for conduct of DDE, detoxification, and rehabilitation services;

WHEREAS, the Bulacan Drug Rehabilitation Foundation, Inc. (BDRFI) is a DOH-Accredited Facility offering individualized assessment, detoxification, rehabilitation, and aftercare services consistent with national standards, and has the organizational capacity to accept endorsed clients from the Municipality of Marilao;

WHEREAS, the Municipal Government of Marilao intends to collaborate with BDRFI through a Memorandum of Agreement (MOA) to establish and implement a comprehensive framework that will benefit individuals affected by substance abuse and promote community-based recovery and reintegration;

WHEREAS, such partnership will strengthen the Municipality's efforts in combating illegal drugs through coordinated, evidence-based, and community-centered interventions;

NOW, THEREFORE, on motion of Honorable Vanessa Valdez-Seminiano duly seconded by Honorable Juanito H. Santiago and upon unanimous vote:

BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Marilao, Bulacan, in session duly assembled, to authorize the Municipal Mayor, Honorable Atty. Jemina M. Sy, for and on behalf of the Municipal Government of Marilao, to enter into and sign a Memorandum of Agreement (MOA) with the Bulacan Drug Rehabilitation Foundation, Inc. (BDRFI) for the application and implementation of a comprehensive drug prevention, treatment, rehabilitation, and aftercare framework in the Municipality of Marilao, Province of Bulacan

RESOLVED FURTHER, that copies of this Resolution be furnished to the concerned agencies for their information, guidance, and appropriate action.
