EXECUTIVE ORDER NO. JS2025-109

AN ORDER ADOPTING AND IMPLEMENTING THE GUIDELINES ON LOCAL NUTRITION PLANNING PURSUANT TO NNC GOVERNING BOARD RESOLUTION NO. 3, s. 2014, AND STRENGTHENING THE FORMULATION, IMPLEMENTATION, MONITORING, AND EVALUATION OF THE LOCAL NUTRITION ACTION PLAN (LNAP) IN THE MUNICIPALITY OF MARILAO, BULACAN

WHEREAS, the National Nutrition Council (NNC), through Governing Board Resolution No. 3, s. 2014, adopted and approved the Guidelines on Local Nutrition Planning to strengthen nutrition governance and local nutrition program implementation;

WHEREAS, local nutrition planning serves as an essential mechanism in identifying nutrition-related concerns and in formulating appropriate nutrition interventions and strategies at the local level;

WHEREAS, the Municipality of Marilao recognizes the importance of strengthening the formulation, implementation, budgeting, monitoring, and evaluation of the Local Nutrition Action Plan (LNAP) in accordance with national nutrition policies and standards;

WHEREAS, there is a need to ensure that nutrition-related programs, projects, and activities are properly integrated in local development plans and adequately supported by appropriate funding and monitoring mechanisms;

NOW, THEREFORE, I, HON. ATTY. JEMINA M. SY, Municipal Mayor of Marilao, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. Adoption of the Guidelines

The Municipality of Marilao hereby adopts and implements the Guidelines on Local Nutrition Planning pursuant to NNC Governing Board Resolution No. 3, s. 2014.

SECTION 2. Formulation and Updating of the Local Nutrition Action Plan

The Local Nutrition Committee (LNC), in coordination with concerned offices, shall ensure the formulation, updating, implementation, monitoring, and evaluation of the Local Nutrition Action Plan (LNAP) in accordance with the NNC Guidelines.

SECTION 3. Integration in Local Plans and Budget

All concerned offices are hereby directed to integrate nutrition-related programs, projects, and activities in the Local Nutrition Action Plan, Annual Investment Program (AIP), and Annual Budget of the Municipality, subject to existing accounting and auditing rules and regulations.

SECTION 4. Monitoring and Evaluation

The Local Nutrition Committee shall regularly monitor and evaluate the implementation of nutrition-related programs and activities and maintain records, accomplishment reports, and supporting documents for monitoring and assessment purposes.

SECTION 5. Support and Coordination

All concerned offices, barangays, partner agencies, and stakeholders are hereby enjoined to support and participate in the implementation of this Executive Order.

SECTION 6. Effectivity

This Executive Order shall take effect immediately upon signing.
