EXECUTIVE ORDER NO. JS2025-113

AN ORDER ADOPTING AND IMPLEMENTING THE PHILIPPINE PLAN OF ACTION FOR NUTRITION (PPAN) 2023–2028 IN THE MUNICIPALITY OF MARILAO, BULACAN

WHEREAS, Article II, Section 15 of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Republic Act No. 7160, otherwise known as the “Local Government Code of 1991,” mandates local government units to promote the general welfare, including the health and nutrition of their constituents;

WHEREAS, the National Nutrition Council (NNC) adopted the Philippine Plan of Action for Nutrition (PPAN) 2023–2028 as the country’s blueprint and framework for addressing malnutrition and improving the nutritional status of Filipinos through coordinated and multi-sectoral interventions;

WHEREAS, the Municipality of Marilao recognizes the importance of adopting and implementing the PPAN 2023–2028 in order to strengthen local nutrition governance, improve nutrition outcomes, and align local nutrition programs, projects, and activities with national nutrition priorities and strategies;

WHEREAS, there is a need to institutionalize and harmonize local nutrition interventions through the Local Nutrition Action Plan (LNAP), appropriate budget allocation, effective monitoring mechanisms, and active participation of all concerned offices and stakeholders;

NOW, THEREFORE, I, **HON. ATTY. JEMINA M. SY**, Municipal Mayor of Marilao, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. Adoption of the Philippine Plan of Action for Nutrition (PPAN) 2023–2028

The Municipality of Marilao hereby adopts and implements the Philippine Plan of Action for Nutrition (PPAN) 2023–2028 as the primary framework in the formulation, implementation, monitoring, and evaluation of local nutrition-related programs, projects, and activities.

SECTION 2. Integration in the Local Nutrition Action Plan

All concerned offices are hereby directed to align and integrate nutrition-related programs, projects, and activities with the goals, objectives, strategies, and targets of the PPAN 2023–2028 in the Local Nutrition Action Plan (LNAP), Annual Investment Program (AIP), and Annual Budget of the Municipality.

SECTION 3. Strengthening of Local Nutrition Governance

The Local Nutrition Committee (LNC), through the Municipal Nutrition Action Officer (MNAO), shall oversee and coordinate the implementation, monitoring, evaluation, and documentation of PPAN-related programs and activities within the Municipality.

SECTION 4. Multi-Sectoral Participation

All municipal offices, barangays, schools, health facilities, partner agencies, civil society organizations, and other stakeholders are hereby enjoined to actively support and participate in the implementation of programs and activities related to the PPAN 2023–2028.

SECTION 5. Monitoring and Reporting

The Local Nutrition Committee shall maintain records, accomplishment reports, and supporting documentation related to the implementation of this Executive Order and shall regularly monitor the progress of nutrition-related interventions and initiatives.

SECTION 6. Funding Support

Funds necessary for the implementation of PPAN-related programs and activities shall be incorporated in the approved Annual Budget and other applicable funding sources, subject to existing accounting and auditing rules and regulations.

SECTION 7. Repealing Clause

All executive orders, memoranda, issuances, or portions thereof inconsistent with this Executive Order are hereby repealed, amended, or modified accordingly.

SECTION 8. Effectivity

This Executive Order shall take effect immediately upon signing.
