**WHEREAS**, presented to this August Body a First Endorsement Letter entitled "Kapasiyahan na nagtitibay sa pagbibigay pahintulot at kapangyarihan kay Punong Bayan Henry R. Lutao, Kinatawan ng Pamahalaang Bayan ng Marilao, na lumagda sa isang Memorandum of Agreement (MOA) sa Philippine Statistics Authority (PSA), kaugnay ng implementasyon ng Birth Registration Assistance Project (BRAP) sa Bayan ng Marilao, Lalawigan ng Bulacan., for its appropriate action;

**WHEREAS**, the PSA created under Republic Act No. 10625 or the Philippine Act which took effect last 12 September 2013 is mandated to collect, compile, analyze, abstract and publish statistical information relating to the country's economic, social, demographic, political affairs and general activities and condition of the people;

**WHEREAS**, the proposed project entitled "Birth Registration Assistance Project for the Municipality of Marilao" aims to increase civil registration in marginalized communities, particularly those belonging to the Indigenous Peoples (IP), Muslim Filipinos, and the poorest sector;

**NOW THEREFORE**, on motion of Hon. Ariel P. Amador, duly seconded by Hon. Juanito H. Santiago and upon unanimous vote by all the Sangguniang Bayan Member present.

**BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to pass a resolution authorizing the Municipal Mayor, Honorable Honorable Henry R. Lutao, to enter into and sign, for and in behalf of the Municipal Government of Marilao, the Memorandum of Agreement (MOA) with the Philippine Statistics Authority (PSA), represented by its Regional Director, Arlene M. Divino, for the implementation of the "Birth Registration Assistance Project (BRAP) in the Municipality of Marilao, Province of Bulacan.

**RESOLVED FURTHER**, that the said MOA shall take effect on the date of signing of both parties and shall valid for the period of one (1) year from the signing of the MOA and may extend for another Three (3) Years from the termination and/or such period as both parties may determine, subject to the performance evaluation result, availability of resources and funds deemed necessary for the operations of the PSA Mobile Registration.
